You are hereby given notice that you are behind on your rent or other amounts due. You are required to either pay everything owed or vacate the premises.

Within three (3) business days (or the appropriate cure period as stated in the lease) you are required to:

2. All occupants must vacate the premises.

If you do not comply with this notice, you will be served with a Summons and Complaint for unlawful detainer. Unlawful detainer is when you remain in possession of rental property after the owner serves you with a lawful notice to leave, such as this eviction notice. If you are found by the court to be in unlawful detainer, you will be evicted and found liable for all amounts owed under the lease and/or Utah law, plus attorney fees, court costs, and three times those damages allowed to be trebled under Utah Code Ann. §78B-6-811. If your lease requires mediation, you must alert us in writing within three days of your willingness to participate in mediation. Mediation shall take place within seven days of receipt of your written notification. If you fail to provide this written notification within three days and/or you fail to participate in mediation within seven days, be advised that your landlord intends to proceed with legal or equitable relief.
